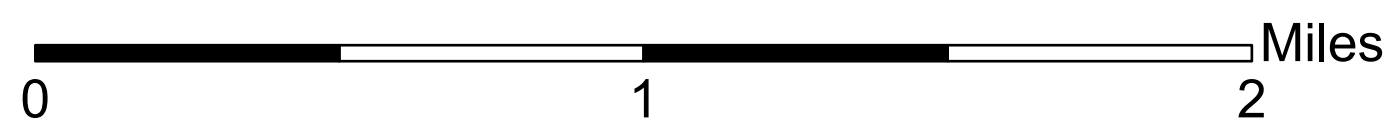
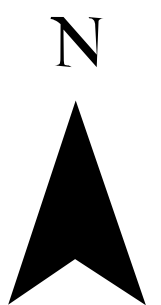
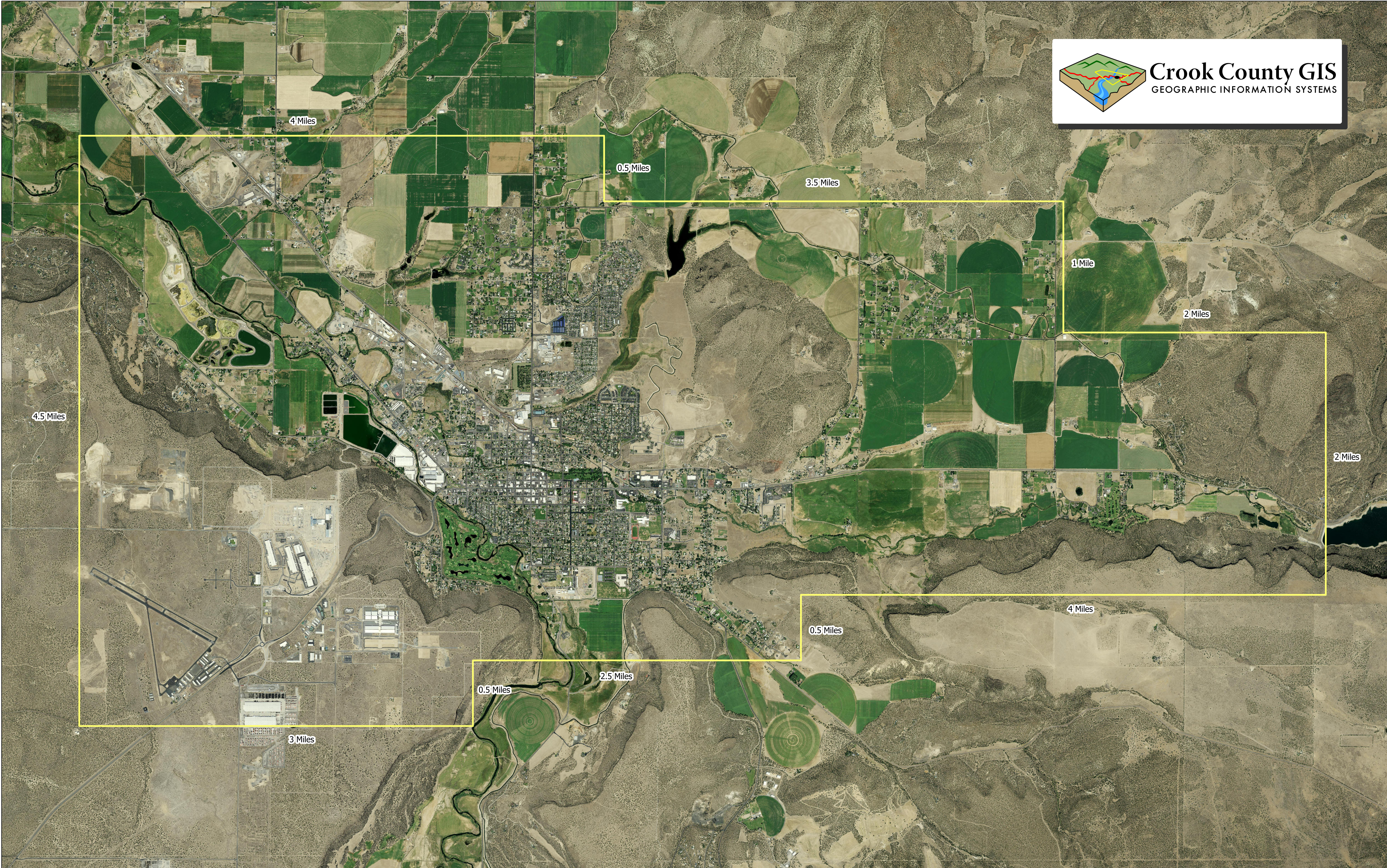


Crook County GIS
